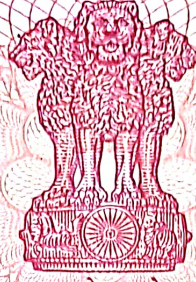

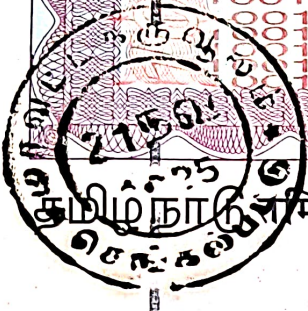

AFFIDAVIT

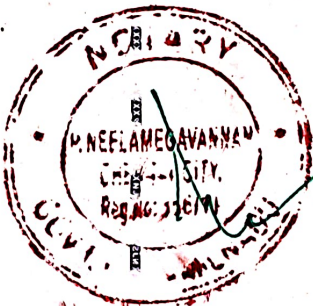

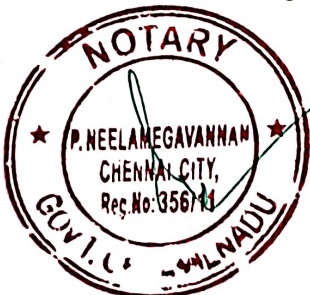

3. No part of income from the institution is being and will be diverted to any individual in the Trust/Society/Company/School Management committee or to any other person/entity. The savings, if any, after meeting the required expenditure and contributions towards educational and creating corpus funds, will further be utilized only for promoting the school and hence extending the purpose of education in the same school.
4. The school is not paying any charges towards usage, logo, motto, or any other non-academic activities to any other institution or organization.
5. The school will not open classes under CBSE Pattern particularly classes XI/XII and will not use CBSE name in any manner without obtaining prior affiliation from the competent authority.
6. The principal and Correspondent/Manager of the school are individually going through the provisions contained in the affiliation & examination byelaws and the circulars issued by the board from time to time. The school undertakes to abide by the provisions contained in the affiliation & examination byelaws, directions issued from time to time and the law of the land.
7. The school will ensure compliance of all statutory requirements such as EPF, ESI and labour laws etc., with respect to the school and staff of the school.
8. School will ensure that Building Safety, Fire Safety, Water Safety, Health and Hygiene certificates are being issued or renewed by the concerned municipal or state authorities from time to time as per the prescribed terms.
9. The school will ensure that the entire required infrastructure is made available before starting classes.
10. The school will ensure that sufficient number of qualified teachers as per the provisions contained in affiliation bye-laws are available with the school before starting classes.
11. The school will follow the provisions related to fee contained in affiliation bye-laws and will disclose the details of the fee to the students/parents every year before commencement of session without resorting to any hidden charges under different heads.
12. The school will not run any 'Dummy School' for the Board classes (classes IX to XII) and will not provide dummy admission to students.
13. The school will strive to create a stress-free environment.
14. The school will ensure that the school funds are utilized for educational purposes before applying for affiliation and will fulfill all other conditions post affiliation and comply with all the general rules given in the affiliation bye-laws as notified from time to time.
15. The school will not start CBSE pattern classes without submitting F&A (Financial and Administrative) Committee Certificate to the effect that the school has complied with all the conditions imposed by CBSE and also the affiliation conditions contained in affiliation bye-laws along with general rules.
